# Use of Privacy policy

Trentwoodensures that your personal data are protected on the legal basis defined in this policy and EU General Data Protection Regulation 2016/679 of 27 April 2016. Trenwood is committed to ensuring that your pesonal data are protected and never misused.

# Purpose of the processing and legal basis

Trentwood may use your personal data for:

- To state institutions to comply with the legal or normative acts obligations;
